

## ACER Decision on amendments to SAP – Annex 1

### **Amendment to the requirements of the Single Allocation Platform according to Article 49 of Commission Regulation (EU) 2016/1719 establishing a guideline on forward capacity allocation and to the methodology for sharing costs of establishing, developing and operating the Single Allocation Platform according to Article 59 of the same Regulation**

Whereas:

- (1) The all TSOs' proposal of 7 April 2017 for the requirements of a Single Allocation Platform (SAP) in accordance with Article 49 of Commission Regulation (EU) 2016/1719 establishing a guideline on forward capacity allocation and for the methodology for sharing costs of establishing, developing and operating the SAP in accordance with Article 59 of the same Regulation were approved by the national regulatory authorities by 14 December 2017 ('SAP requirements and cost sharing methodology 2017').
- (2) The all TSOs' proposal of 7 April 2017 was not approved for the TSO Fingrid Oyj, but, in accordance with Article 30(7) of Regulation (EU) 2016/1719, the SAP requirements and cost sharing methodology 2017 should now apply to it. Therefore all TSOs proposed to amend the approved all TSOs' proposal of 7 April 2017 so as to make it applicable also to Fingrid Oyj.
- (3) The scope of application of the SAP requirements and cost sharing methodology 2017 should therefore be amended to include also Fingrid Oyj.
- (4) Accordingly, this document amends the SAP requirements and cost sharing methodology 2017.

#### Article 1

Amendment to Article 1 of the SAP requirements and cost sharing methodology 2017

In Article 1 the following paragraph shall be added:

*(6) The present requirements for the SAP and the present methodology for sharing costs of establishing, developing and operating the SAP shall apply to the TSOs listed in Annex 1.*
